

# COMPULSORY CPD TOPICS SUGGESTED BY GREEK DENTISTS

## Introduction and Aim

The DentCPD project aims at the Harmonization and Standardization of European Dental Schools' Programs of Continuing Professional Development (CPD) for Graduate Dentists. One of the objectives is to develop agreement on core CPD components.

The aim of this presentation was to investigate the opinion of a sample of Greek dentists on which CPD topics out of a list of 13 should be compulsory

## Methods

European Dental Schools, Dental Associations and others were initially online surveyed to indicate which CPD topics out of a list of 23 were currently compulsory in their country, and which topics they thought should be compulsory. There were 143 responses from 30 EU member and candidate countries. Thirteen topics achieving at least 50% agreement were further presented to sample groups of dentists in four EU countries asking them to indicate which of them should be compulsory. The original paper-based questionnaire was translated in Greek and distributed to dentists attending a CPD course organised by the Athens Dental Association in April 2011.

## Conclusions

The three most commonly suggested compulsory topics for the Greek dentists were: a) medical emergencies and cardiopulmonary resuscitation, b) the medically compromised patient and c) cross infection control/ decontamination and disinfection. Those three topics were highly rated by respondents in other similar surveys across Europe, indicating common educational needs among European dentists. Those views should be taken into consideration in discussions for consensus on core CPD components.
